## **2006 Congressional Report on Jamaica's Enterprise for the Americas Initiative (EAI) Fund**

---

## **Jamaica**

In 1991, the Environmental Foundation of Jamaica (EFJ) was established out of two bilateral debt reduction agreements between the Governments of Jamaica and the United States of America. The two funds created reduced USAID and PL480 debt by \$311 million. The interest on the remaining \$95 million is projected to provide the Fund with a total of \$21.5 million over a 19 year period to 2012. Operations of the EFJ began in May 1993.

### **Mission Statement of the Environmental Foundation of Jamaica (EFJ):**

The mission of the EFJ is to serve the public good by promoting and implementing activities designed to conserve and manage the natural resources and environment of Jamaica in the interest of sustainable development and to improve child survival and child development.

### **Major Achievements in 2006**

This report covers the achievements within the fiscal year August 1, 2005 – July 31, 2006. Guided by its Strategic Plan (2004-2009), the EFJ has accomplished the goals set out in its Annual Work Plan. These include:

- ❑ **An Evaluation of the first 10 Years of its Grant Making.** The evaluation confirmed that the EFJ's grant making has had an impact in many communities across the country;
- ❑ **A Review of our 5-year Strategic Plan** which confirmed the relevance of the EFJ's main strategies and identified new ones which have been incorporated in the 2006-2007 work plan;
- ❑ **A "Call for Proposals"** – in which 305 proposals were reviewed, and 77 approved for funding. For 2005/06, disbursements of **JMD\$274.74M** were made to a total of 147 projects;
- ❑ **The introduction of a Discretionary Grants Programme** which allows grantees to access up to JMD\$200,000 within each fiscal year, outside of the Call System. The programme increases the responsiveness of the EFJ to the needs of our grantees. In the first year, 7 projects were funded for a total of JMD\$1,032,000.00;
- ❑ The EFJ enhanced its grant making programme with the introduction of the **GIFTS** grant management software, designed to support improved data gathering, response time, analysis, and facilitate easier access to grantees' information in particular in terms of reporting and monitoring;

- In continuing to develop our role in public education and awareness, the EFJ launched its **Annual Public Lecture Series** with the Inaugural Lecture focusing on the environment. It was delivered by Prof. The Hon. Gerald Lalor and was entitled “Earth and Its Environment”. The EFJ also facilitated the participation of its grantees in sharing their work and experiences in a seminar series during the Jamaica Foundation for Children’s **Annual Children’s Expo**;
- As part of an on-going process to improve operational efficiencies and maintaining fiscal prudence, the EFJ continued to revise and update all internal policies, particularly in the areas of human resources, procurement, asset acquisition and management.

### **Secretariat Management**

The Board of Directors of the EFJ continued their active involvement in the organization and commitment to fiscal prudence and sound management of the Foundation throughout the year. The administrative expenses of JMD\$55M amounted to 20.06% of grant disbursements, well within the allowable ceiling of 25%. Towards this end:

- The Grant Management Committee met 9 times during 2005/06; the Finance Committee 5 times; The Human Resources and Compliance Committee 4 times and the Board of Directors 7 times.
- A new Chief Executive Officer was hired in June 2006.

### **Grant-Making Activities**

Since 1993, the Foundation has approved funding for 931 projects totalling JM\$1.702B. The 10-Year Evaluation pointed to successes and lessons learned, and has reinforced the EFJ’s goal of continuing to adopt a programmatic approach to grant making and to improving its impact assessment. The themes for the March 2006 Call were:

#### **a. Environmental Management and Natural Resource Conservation:**

- Biodiversity, with a focus on:
  - Habitat conservation and management
  - Public awareness and education
- Alternative Energy

#### **b. Child Survival and Development:**

- Children in challenging circumstances, with a focus on:
  - Abuse and Violence Prevention
  - Abandoned and Institutionalised Children
  - Children Affected by STI’s, including HIV/AIDS

- Children with Special needs and disabilities, with a focus on:
  - Training for child development facilitators

## Impact Assessment

The EFJ’s grant making has had impacts in several areas within the Child and Environment sectors.

### Child Survival and Development

The EFJ is the largest donor in the area of children with special needs and disabilities. Within the 2005/06 fiscal year, the amount of grants funded in this theme totalled JMD\$17,524,500. Notable grantees in this category included :

- **The Jamaica Association for People with Mental Retardation** (Developmental Disabilities) - JMD\$5,000,000; **3Ds project**, a rural NGO providing valuable research, testing and support to children with disabilities and their parents – JMD\$5,999,400; **St. Christopher’s School for the Deaf** – JMD\$1,160,000.00. These three organizations alone reached in excess of 10,000 children. A diversity of support has been made available for education equipment, training for caregivers, parents and teachers and social development.

- The use of the programmatic approach, through the Call system, aligned with the organization's strategic plan, and national priorities are the hallmarks of the EFJ's successes in the Child Survival and Development area. This approach can be particularly demonstrated in our partnership with the **Dudley Grant Memorial Trust (DGMT)**, an organization dedicated to impacting national policies and programmes related to Early Childhood Development.

So far, in a three year partnership with the Dudley Grant Memorial Trust, 200 early childhood practitioners have received training to upgrade their qualifications through a nationally accredited programme; 50% of Parishes in Jamaica now have Early Childhood Development Resource Centres for use with students, parents and by teachers, with the others to come on stream. This is in addition to research carried out that has informed government policies and programme.

- Other EFJ funded research in the Early Childhood Development area include the **University of the West Indies – Child Development Research Group** – JMD\$3,419,340.00 and the **Section on Child Health** – JMD\$3,657,500.00. These projects have impacted the programme of work of the newly established Early Childhood Commission.
- The EFJ has funded the development of a comprehensive manual on parenting, entitled **“Pathways to Parenting – A Caribbean Approach”**, used by organizations, schools, agencies and parents in Jamaica and the wider Caribbean.
- JMD\$14,479,013 were awarded in 2005/06 to the benefit of Basic Schools. This included grants to NGOs/CBOs, such as the **Gravel Hill Basic School** (JMD\$1,680,000) and the **Clifton and Mount Peace Citizens' Association** (JMD\$1,567,500) for infrastructure improvements, educational materials and teacher training.
- The EFJ continues its partnership with the **Bernard van Leer Foundation's** “Kingston Inner City Child Support Project” dedicated to the training and accreditation of Early Childhood Development practitioners.

## **Environmental Conservation and Management**

Within the Environment Sector, there has been noticeable impact, within the different themes. Examples include:

- **Habitat Conservation and Management** - the work done by grantees such as the **Jamaica Conservation and Development Trust (JCDDT)** in the John Crow and Blue Mountains (JMD\$6,261,000), has resulted in local farmers abandoning the ‘slash and burn’ mode of farming in favour of sustainable farming practices and alternative livelihoods such as eco-tourism (opening of the historic Maroon Trail the Cunha, Cunha Pass). Another grantee in the sensitive Dolphin Head Mountain area of Hanover, **Dolphin Head Trust (DHT)**, has successfully engaged farmers in the buffer zones to also adopt sustainable farming practices, and alternate livelihoods such as the creation of hiking trails and a bamboo furniture business;

- Funding towards **Public Education and Awareness** within the Environment sector has had a major impact at the national level. Multi-year funding to one of our grantees, **Jamaica Environment Trust (JET)** to develop and implement a Schools Environment Programme (SEP) – JMD\$4,493,276 in 2005/06, has resulted in that programme being integrated into the national education system. JET now works in partnership with the Ministry of Education and the Joint Board of Teacher Education (JBTE) towards system-wide implementation of the programme;
- Outputs of grantees engaged in the area of **Biodiversity and Watershed Management**, have resulted in the successful reforestation of critical watersheds such as the Dunn’s River Watershed (240 hectares of reforestation), which also saw the creation of a strong Community Based Organization, **Hills United Development Organization** by communities in the buffer zone. Within 2005/06, funding to organizations such as **LaZin Farmers** (JMD\$5,997,000) in the Rio Cobre Watershed, and to the **Yallahs Development Area Committee** (JMD\$5,967,000) in the Upper Watershed of Yallahs River are well on the way to duplicating this success.
- **Water and Sanitation** issues continue to plague a number of urban and rural communities. The EFJ has successfully supported water and sanitation projects, which allowed communities to act in partnership with the Ministry of Water and local government authorities. Through these projects, in 2005/06 year alone, in excess of **7,000 people** have been positively affected with access to safe water and appropriate sanitation. This is key in supporting Jamaica’s commitments to achieving the Millennium Development Goals target of halving the population without safe water and appropriate sanitation by 2015.

### **NGO Strengthening – Capacity Building**

The EFJ continues to facilitate the capacity building of its grantees in several ways. These include:

- Strengthening their governance structures through board development and strategic planning;
- Strengthening technical skills, through sponsoring participation in education and training programmes;
- Strengthening project management processes;
- Proposal writing; and more recently
- Support towards financial sustainability.

In 2005/06, the EFJ supported training activities administered by grantees to a number of NGOS/CBOs. These include:

- A grant in the amount of JMD\$5,890,000 to the **Association of Development Agencies (ADA)**, was used to successfully administer a training programme in partnership to 50 NGOs/CBOs, in partnership with the University of the West Indies. Certificates were awarded for a course in project management, monitoring and evaluation (within the environment) and one credit was earned through the UWI's accreditation system;
- The **University of the West Indies, Development and Endowment Fund** received support in the amount of JMD\$3,300,000 to facilitate the strengthening of NGOs/CBOS in resource mobilization, at its 2nd Conference on Caribbean Philanthropy.

The EFJ continues to support the needs of grantees through workshops on proposal writing, building their project management skills through connecting them with resource persons (e.g. financial management, evaluation) and with governance related issues (e.g. strategic planning).

### **Fund Management**

The EFJ is governed by a Board of Directors comprised of nine representatives. The membership includes representatives from the U.S Government, the Government of Jamaica, and the University of the West Indies (UWI), the Child Survival Sector, and five environmental NGOs. The Board operates through five standing Committees: Executive; Finance and General Purposes; Grant Management; Human Resources, Compliance and Compensation; and Membership.

Due to Jamaica's common law heritage, the Foundation's governance is structured like that of a corporation. There are 42 member NGO organizations that subscribe to the principles of the EFJ as its "shareholders." The membership is served by a Secretariat with staff of 20. It operates through three departments under the direction of the Chief Executive Officer: the Program and Grant Management Department, the Finance Department and the Human Resources and Administration Department.

### **Leveraging EAI Funds**

As reported last year, the EFJ is the first and only environmental Fund to participate in the USAID's Development Credit Authority (DCA) program. The U.S. Government, RBTT Bank Jamaica Limited, and the EFJ formally launched the DCA, Loan Portfolio Guarantee Project in late 2004. The EFJ provides 40% (US\$2M) of a US\$5M loan pool, targeted at small and medium sized enterprises in the hotel/tourist and manufacturing sectors. The venture is known as the "Go Green Facility" and US\$1.2M in loans have been approved by RBTT to six (6) small and medium sized private sector enterprises for use in environmentally friendly projects.



Dividends continue to accrue on the equity investment in Walkerswood Partners Limited (WPL) and the first payment of JMD\$11M becomes due at the end of February 2007.

### Sustainability

The EFJ's Finance Committee and Board continue to monitor investment yields from all accounts and a financial analyst is employed do so on a full-time basis. Negotiations for a second generation of funds are underway, as well as plans to capitalize the EFJ's Endowment.

### Partnerships

As the selected Fund Administrators for the new **Forest Conservation Fund (FCF)**, established under the Tropical Forest Conservation Act (TFCA), the EFJ has embarked on a partnership with the Jamaica Protected Areas Trust (JPAT). In addition, a new partnership has been established with the Global Environment Facility (GEF) – Small Grants Programme. The EFJ is a member of its National Committee and the goal is to engage in a number of co-financed projects. EFJ continues its partnership with the Bernard van Leer Foundation (BvLF) in Phase Two of the BvLF's Kingston *Inner City Child Support Project*.
